It is recommended that the data herein presented be given formal consideration by the Board of County Commissioners (BCC).

DESCRIPTION AND CONDITIONS:

Effective October 1, 2009, the U.S. Department of Housing and Urban Development (HUD) approved Pasco County's Fiscal Year 2009-10 Community Development Block Grant (CDBG) funding. The total allocation of funds has been divided among several projects approved by the BCC on June 9, 2009. The attached agreement is between Pasco County and the City of New Port Richey, in the amount of \$222,052.00, for the repaving/resurfacing of Nebraska Avenue and the parking lots adjacent to the Railroad Square Project, Phase II; eliminating existing problems with storm drainage patterns in the construction area; replacing and installing sidewalks with handicap accessibility; and constructing pedestrian walkways, street lighting, and landscaping. The project area will extend between the intersections of Grand Avenue and Lincoln Street. The balance of the total cost of \$500,000.00 will be provided through the Community Redevelopment Area (CRA) funds in accordance to Chapter 163 of the Florida Statutes. The project must be completed by September 30, 2011.

ALTERNATIVES AND ANALYSIS:

1. Approve the attached agreement between Pasco County and the subrecipient mentioned, thus allowing Pasco County to expend grant funds as approved and received under the CDBG program.
2. Deny the attached agreement, which will cause a delay in this project.

RECOMMENDATION AND FUNDING:

The Community Development Division recommends that the BCC approve the attached agreement, authorize the Chairman to execute the three original agreements provided, and direct the Board Records Department to distribute the agreements as follows: retain one original; one original to the Community Development Division, New Port Richey; and mail one original to:
