It is recommended that the data herein presented be given formal consideration by the Board of County Commissioners (BCC).

DESCRIPTION AND CONDITIONS:

Effective October 1, 2009, the U.S. Department of Housing and Urban Development approved Pasco County's Fiscal Year 2009 Emergency Shelter Grant (ESG) funding. The total allocation of funds has been divided among several programs. The attached agreement is between Pasco County and The Salvation Army, A Georgia Corporation, Domestic Violence Shelter of the Salvation Army of West Pasco County, in the amount of \$41,126.00, to provide emergency shelter to women and children who are victims of domestic violence and services to adults and children survivors of sexual assault County-wide for the period of October 1, 2009, through September 30, 2010.

ALTERNATIVES AND ANALYSIS:

1. Approve the attached agreement between Pasco County and the subrecipient mentioned, thus allowing Pasco County to expend grant funds as approved and received under the ESG program.
2. Deny to approve the attached agreement will cause a delay in this program.

RECOMMENDATION AND FUNDING:

The Community Development Division recommends that the BCC approve the attached agreement, authorize the Chairman to execute the three original agreements provided, and direct the Board Records Department to distribute the agreements as follows: retain one original; one original to the Community Development Division, New Port Richey; and mail one original to:
