**OVERVIEW:** In celebration of its' 82<sup>nd</sup> anniversary of New Port Richey's

founding, Main Street's Founders Day Celebration, paid homage to the settling of the area in the early 1900's. The 2006 Founders Day Celebration featured a variety of live, thematic entertainment, a carnival and midway, demonstrations and activities in the Hickory Hammock area (so named because it was the city's original name) that included an interactive display of antique engines, and old time skills like candle making and woodcarving. The event also offered a two-day arts and crafts fair, and a classic car show situated

around picturesque Orange Lake.

The Founders Day Celebration 2006 was host to non-stop live musical entertainment on three stages with an eclectic mix of regional musical entertainment ranging from 20s Jazz to Rockabilly and included some down home Florida Folk music. The Friends of Florida Folk musicians entertained crowds in the peaceful ambience of Peace Hall church, which lent itself to the acoustic musicians who performed.
