I. <u>Call to Order</u>

Chairman Kennedy called the meeting to order at 10:04 a.m.

Chairman Kennedy led the Pledge of Allegiance.

Mr. Rune Lero, Building Official, gave the invocation.

1. Roll Call

Mr. Timothy Moore, Building Official, called the roll. All members were present except Mr. George Maniates and Mr. Thomas Drunasky. Ms. Cynthia Jolly was absent.

2. Administration of Oath

Ms. Russo administered the oath to all those who planned to testify.

II. Minutes

There were none.

III. Proposed Rules and Regulations or Other Business

1. Building Official's Comments

Mr. Lero said this was the first meeting of the Pasco County Construction Board, which was a reflection of the new Ordinance adopted by the Board of County Commissioners. All cases, both licensing and investigation, would be heard by the same Board.

Mr. Lero said that next month's hearing, on November 15, 2007, would be in New Port Richey and that there would be a recess for lunch because it was expected to be a heavy agenda.

2. County Attorney's comments:

Ms. Wooden pointed out that the new Ordinance concerning requests for reduction and/or waivers of fine stated that any person may submit their request in writing and the Board could respond in a like manner. She explained further the portions of the new Ordinance that directly affected the Construction Board. She cautioned the Board members not to discuss the written or submitted cases except at the meeting due to the Sunshine Laws.

IV. Hearing of Appeals

1. CLB2007-028 Christian Lube

Mr. Lero explained that the applicant had been denied a painting contractor's license because the application did not provide sufficient proof of experience and because the financial responsibility section was unacceptable. He explained further.

Mr. Christian Lube explained his situation and was willing to provide further information.

MR. TUCKER MOVED to accept evidence submitted by Mr. Lube; MR. BLACK AND MR. GOTTBERG SECONDED.

Chairman Kennedy called on the motion; the vote was unanimous and the motion carried.

Further discussion followed between the Board, Staff, and the applicant. Staff withdrew one of the reasons for denial, the lack of proof of experience, but the other reason,

financial responsibility, remained intact. The County Attorney reviewed the specifics of the denial.

MR. CARROLL MOVED to uphold the Building Official's decision; MR. BLACK SECONDED.

Chairman Kennedy called on the motion; the vote was unanimous and the motion carried.

It was suggested Mr. Lube reapply with further information for the Building Department.
