Proposed Settlement

Dear Mr. Atkinson:

The Pasco County Board of County Commissioners at its August 9, 2011 Board meeting reviewed this matter and authorized me to provide the following.

We investigated the 31 properties for which the Fows alleged the County approved a roof. Of the 31 properties, 15 have roofs that were built prior to 2007 when the dock permitting program began; three do not have roofs; six have roofs built without a permit (for these a dock permit was issued but a roof was not included); and for the remaining seven, the County mistakenly issued a dock permit that included a roof. These seven roofs were permitted to be constructed only over boat lifts. None of these seven permits allowed a roof over the entire dock as requested by the Fows. The largest of these permitted roofs covers two side by side boatlifts, and the roof is approximately 576 square feet (s.f.) in size. The attached chart shows the results of our investigation.

The Board rejected your settlement offer; however, the County proposes a counter-offer to allow the Fows to construct, as a legal non-conforming structure, a roof over their existing boatlift, provided that such roof does not exceed 600 s.f. in size. The roof must also meet applicable building code and Dock Ordinance requirements. These requirements would make the Fow's roof consistent with, and similar in size and scope to, the seven roofs permitted by the County since the dock permitting program began. The County takes no position as to the issue of whether this roof is prohibited by the deed restrictions of the community.
