It is recommended that the data herein presented be given formal consideration by the Board of County Commissioners (BCC).

## **DESCRIPTION AND CONDITIONS:**

The Pasco County Real Estate Division has received the following Agreement for Sale and Purchase of Interest in Property for the Moon Lake Road Project No. C9528.00.

An offer was made to the property owner for the appraised value and was not accepted. Negotiations between the County's representatives and the Owner's Attorney were carried out with an agreed price of \$110,000.00 being the accepted price. Pasco County is responsible for the Seller's costs. These costs include Seller's attorney's fees in the amount of \$5,280.00 and Seller's appraiser's fees in the amount of \$4,968.00. In addition, the amount of \$850.00 for the title insurance policy per paragraph five of the agreement would be paid by the county. This was presented to the Condemnation Review Staff and approved for recommendation to the BCC.

#### **ALTERNATIVES AND ANALYSIS:**

- 1. Approve the attached Agreement for Sale and Purchase of Interest in Property.
- 2. Disapprove the Agreement and continue to acquire the parcel through condemnation.
- 3. Discontinue the Moon Lake Road Project.

## **RECOMMENDATION AND FUNDING:**

The Engineering Services Department recommends that the BCC approve Alternative No. 1, authorize the Chairman to execute the four original agreements attached, and further direct the Board Records Department, Dade City, to retain one original executed agreement; forward two original executed agreements to the Real Estate Division to the attention of Lisa Kral; forward one copy of the executed agreement to the Office of the County Attorney; and one executed original to the Office of Management and Budget, all of New Port Richey. It is further recommended that the Chairman instruct the Clerk to issue two checks, one check in the amount Eight Hundred Fifty and 00/100 Dollars (\$850.00) for title insurance, and the second check in the amount of One Hundred Twenty Thousand Two Hundred Forty-Eight and 00/100 Dollars (\$120,248.00) for the parcel.
