It is recommended that the data herein presented be given formal consideration by the Board of County Commissioners (BCC).

## **DESCRIPTION AND CONDITIONS:**

On August 8, 2006, the BCC accepted a cash bond maintenance guarantee (as submitted by Palm Pointe, LLC), in the amount of \$149,680.50, for the subject project. This cash bond was provided in accordance with Pasco County's ordinances and policies to provide for maintenance of the project's utility improvements for a period of one year.

The maintenance guarantee has been satisfied, and the Utilities Services Branch has determined that the cash bond can be released in accordance with Pasco County's ordinances and policies.

Palm Point, LLC, has issued Assignment of Declarant's Rights (attached) to Country Walk Developers, LLC; Cardel Master Builders, Inc.; and Standard Pacific of Tampa, f.k.a. Westfield Homes of Florida.
