

## **UNIFORM FINE SCHEDULE**

All violations are subject to court costs, as allowed by law. Court costs are not included in the fine amounts listed above.

All violations of the Pasco County Land Development Code not otherwise designated below shall be deemed to be Class III offenses. All violations of the Pasco County Code of Ordinances not otherwise designated below shall be deemed to be Class IV offenses.

Fines shall be doubled for a second offense and for each subsequent offense thereafter, unless a different fine schedule for subsequent offenses is set out below. Third and subsequent violations, certain animal control violations, and certain violations posing a serious threat to public health, safety, or welfare require a mandatory court appearance.
