Daily responsibilities involved a wide array of management practices, projects, surveys, and recovery efforts benefitting the endangered Red Cockaded Woodpecker (RCW). Tasks included the installation of artificial inserts, drilled starts, and drilled cavities in old growth Long-leaf pine trees. Census/Survey efforts included seasonal monitoring using scopes, cameras, nets, leg bands, as well as translocation efforts. Management practices involved the use of GPS technology in order to determine the feasibility of potential RCW clusters and the condition of existing clusters. Prepared RECs (Records of Environmental Consideration) for thinning recommendations in order to comply with NEPA regulations. Habitat management involved the use of chainsaws and heavy equipment style mulchers to accomplish thinning in sites too small or too difficult to access for contract loggers. Non RCW related tasks involved the assistance with, development of, and participation in individual monitoring projects.
