EXPANSION OF SHADY HILLS WASTEWATER TREATMENT FACILITY

The Pasco County Purchasing Department will receive sealed bids until **2:00 p.m.**, local time (our clock), on **JULY 12, 2007**, in the Pasco County Purchasing Department, 8919 Government Drive, New Port Richey, Florida 34654. Bids received after this time will not be accepted. Bids will be publicly opened and read at the above-stated time and date. All interested parties are invited to attend. Bidders shall submit one (1) original of the submitted bid.

The work consists of an expansion to the County's existing Shady Hills Subregional Wastewater Treatment Facility (WWTF) from 2 MGD to 14 MGD. This project includes: one (1) 5-MG ground storage tank; one (1) headworks structure; two (2) splitter boxes; four (4) anoxic basins; three (3) aeration basins; modifications to an existing aeration basin; two (2) internal recycle pump stations; one mixed liquor splitter box; four (4) clarifiers; modifications to existing clarifiers; two (2) RAS pump stations; two (2) sludge holding basins; seven (7) deep bed filters; chlorine contact chamber; one (1) chemical feed building; administration building; blower building; high service pump station; plant drain pump station and mud well pump station; 14-MG reject water pond; effluent metering and controls; truck scale system; standby power generator system; instrumentation and controls and SCADA system; and modifications to the existing roadways. The work includes material, labor, equipment, instrumentation, controls, piping, valves, fittings, earthwork, and all other ancillary components required to fully complete the construction of the specified system. Please refer to the contract documents and specifications for a complete description of the work. This project is estimated to cost **\$72,000,000.00**.

A non-mandatory pre-bid conference will be held in the Purchasing Department Conference Room; 8919 Government Drive; New Port Richey, Florida, on **JUNE 15, 2007**, at **10:00 a.m.** All interested parties are strongly encouraged to attend. The purpose of the pre-bid conference is to allow potential bidders an opportunity to present questions to staff and obtain clarification of the requirements contained in the issued bid documents.
